The invocation was given by Pastor Clark Genet followed by the pledge of allegiance.

Melissa Show read a statement regarding the current situation with the income tax rate.

Citizens Forum

Brian Bell -256 Baker Street - stated that he has respect and gratitude that diligence of the administration found the error and made no attempt to cover it up. This is not an easy situation for anyone. We are lucky to have the leadership that we do.

Rich Barnett – 43 Sheldon Street – stated that he is disappointed. Council knew in the third quarter, yet he is just now hearing about it. He doesn't understand why it took three months to sort out. Why did it take three months to communicate to the public? Will public records be available to review? Why has this been covered up? Was the delay intentional? Which code state that Ohio Revised Code allows one year for payment?

Tara Boler – 8 Fairmont – stated she is not here to complain. She said she had solutions and that Council should take them under advisement. She has looked at the budget and there are things that need to be cut. We do not need a splashpad at Fritz Park. How much is software for Civics Plus? We need to liquidate the rec center. Sell it. Sell the Preserve to the Metro Parks. The City would be able to access those funds to make up for this egregious mistake that was made in 1997. She doesn't think Council should be allowed to renovate the current library space when they get the new one built. That is going to take money that the City does not have. If you decide to put the tax increase on the ballot she has a feeling it will get voted down.

Justin Johnson – former resident of Rittman currently lives in Uniontown – he stated he was attending on behalf of the Libertarian Party as he was contacted by residents of Rittman to provide assistance. According to the ordinance to put the tax levy on the May 2 ballot this year. His suggestion is that the Council delays on that decision due to the fact to allow an outside investigative service to look further into the taxation of the city or other financial areas. If there was .5 that was forgotten for 15 years what else could there be? He knows what the citizens truly want is accountability for where their tax dollars really went. What would happen to him if he didn't pay his taxes for 15 years? It could destroy peoples lives. What he has seen tonight is that everyone has been open and honest. This will become a national story.

Tara Boler – (Mayor Robertson stated she could address more next Monday). She stated she received a letter from the city that they threatened to fine her and put her in jail over a dead tree on her tree lawn. She had further comments regarding the tree. She stated as a taxpayer she could be threatened with jail time and a fine. When you come at her hard nosed she is upset and the same respect she was shown is the same respect that the citizens expect. Why did the city use the code for one year repayment and not the one that recoups three years? She called the Ethics Committee in Columbus and they were appalled. The people who did this and overlooked it don't work in the city any longer. She stated that she doesn't think anything criminal occurred. We are asking for some manner of relief and fairness to the rest of the public; one year is not sufficient.

Ray Rigas - 97 N. Third Street - stated that people are upset because of the way the letter came across. It said we made a mistake but the law says that we don't have to pay it back. Mr. Rigas inquired if there could be credit somewhere in the future for people. Many
