Why do you choose to use the Ohio Revised Code that was quoted in the letter? As far as refunds go.

When the mistake was discovered, was it the elected officials or was an unelected official? And who exactly said we're not going to tell anybody until the statute of limitations comes.

Should that half percent get voted back in? And I know you haven't got this part yet, but the question is. Should that happen? And are you guys going to think about something significant that you can do to get back to us? We know you can't get money back because there's something else you can do significant to get back there.

We have roughly 6,000 residents. Do you know the percent or the number of residents that actually file taxes with the city? What number of percentages live here and work here versus live here and work in another municipality?

I'm looking at some of the expenses. That the city has, and in this economy, we've all had to tighten our belts. What is the city going to do about that? From what I understand and what I'm able to read between the lines, it looks like we are paying for the city managers, vehicle maintenance and fuel and insurance, and I'm pretty sure she's allowed to drive back and forth from work to home and we're paying for miles as well. Can you verify if that is the case?

And my follow-up question is that being the case, what other cuts are you guys looking at? Because we're all making cuts for you and you want us to give you more? And I'm not seeing where this is actually helping, and there's a lot of budget shortfalls. And why were bonuses paid out for longevity to administration? Some of them were over \$10,000, according to the financials. When you already knew that the city was going to be strapped for cash.

Why are most actions taken by the Council declared a state of emergency, but paying the citizens back is not?

How are you guys using the extra money that you guys are stealing from the residents and those who work here?

You made the comment that you're doing the right thing by refunding one year's worth of taxes. You know that isn't really doing the right thing. That's doing the legal thing. I'd like to know where the money went because the roads are crap. These are the worst the roads.

And then the rec center. How much money are they bringing in? Because I mean, they should be bringing in a ton with a family of \$428.00 for a family, for a membership, for a year. That's ridiculous. Half of us can't even afford that.

I live on 3rd St. I was at the meeting last week and you guys said you found this in the third quarter, but yet we weren't notified until after the first of the year. That puts it outside of the statute of limitations. This was brought up in the meeting last week, but you guys weren't taking questions or responding. I just wanted to hear the response to that because by keeping us under wraps for three more months. You made it to where we can't come back and get 1/2 percent for those years. And then, you know, I voiced my concerns last week, the letter kind of came out. It's a little hard, I'm going to be honest with you, nobody likes reading that. Hey, here's what we did. The laws on our side, we're not getting anything back. And then at the same time you want to go for a vote for 1 1/2%. How much does it cost to put that on the ballot? How much taxpayers' dollars does it cost?

RESOLUTION NO. 8344

A RESOLUTION OF THE COUNCIL OF THE CITY OF RITTMAN, WAYNE AND MEDINA COUNTIES AND STATE OF OHIO, EXPRESSING THE INTENT TO SELL PERSONAL PROPERTY INCLUDING, BUT NOT LIMITED TO, VEHICLES, EQUIPMENT, TOOLS, AND SUPPLIES THAT ARE NO LONGER NEEDED FOR PUBLIC USE, OR ARE OBSOLETE OR UNFIT FOR THE USE FOR WHICH THEY WERE ACQUIRED BY INTERNET AUCTION IN ACCORDANCE WITH OHIO REVISED CODE 721.15 AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code §721.15 authorizes this Council to adopt a resolution to authorize the sale by internet auction of personal property owned by the City, including motor vehicles, referenced in §721.15 which are no longer needed for public use or obsolete or unfit for the use for which they were acquired; and

WHEREAS, the City has determined that selling such property via internet auction is likely to yield higher returns than other methods of sale.

NOW, THEREFORE, be it resolved by the Council of the City of Rittman, Counties of Wayne and Medina and State of Ohio, two-thirds of all members elected and appointed thereto concurring:

SECTION ONE.

This Council hereby expresses its intent to sell personal property that is not needed for public use, or is obsolete, or unfit for the use for which it was acquired, by auction including but not limited to internet auction for the calendar year 2023.

SECTION TWO.
